3. Introduction

3.1 Document Purpose

This document is intended for TRAKPAK clients who wish to produce labels from their own systems and transfer data to P2P for shipment processing.

3.2 Testing Procedures

All clients wishing to process TRAKPAK shipments in this way must first get approval on label formats and transfer files.

All test data including physical labels must be sent in order to get live settings.

For testing purposes the following settings should be used:

Field	Test Setting
Site Code	P2P001
Number Range	90000001 - 900009999

The test data should include a selection of labels and at least one data file based on your intended shipping profile. Please consult your P2P contact to agree details.

All test packs (Label images and data files) should be initially emailed to clientitsupport@p2pmail.co.uk for approval.

Once confirmed FTP Access details will be supplied and physical labels required for final approval.



4. Label Design

4.1 Label Format

Labels are designed to print to 6*4 thermal labels Other labels can be used on approval by P2P – please consult your P2P contact.

Below images are the standard layout printed in portrait – labels printed in landscape can be used – please refer to notes on barcode positioning to ensure your layout will conform to basic requirements.



- 1. Please refer to section 4.2 for the barcode format
- 2. The address should be laid out clearly with the Postcode (where used) in a larger font as shown above
- 3. Please refer to section 4.3 for the barcode requirements
- 4. Always print the destination Country ISO code here in bold
- 5. Trak Pak logo client may switch this to print their own logo if desired
- 6. Trak Pak consignment number

This barcode should have a maximum of 6mm space between the barcode and the edge of the label This barcode should be placed at the top of the label



4.3 PDF417 Barcode

This barcode is designed to ensure basic, minimum data for the consignment is included on the label – in event a consignment has no data available from FTP Message transfers – this barcode will be used to generate basic consignment data. This barcode is made up of the following fields, separated by comma (csv format):

5. File Transfers

5.1 Transfer Method

All files to be transferred to P2P prior to goods arriving at the relevant P2P Hub – failure to provide the required data files to P2P may result in delays to the processing of your consignments

Files are to be transferred via FTP – details will be provided during your testing & approval process

5.2 File Naming

All data files created must follow the following naming convention: DDMMYYYYHHMM.CCCCCC

DD	Day Date of file creation
MM	Month Date of file creation
YYYY	Year Date of file creation
нн	Hour of file creation (using 24 hour clock)
MM	Minute of file creation
CCCCCC	Site Code of sending Client

So a file generated for Client Site P2P001 on 1^{st} July 2015 at 5.32pm would be: 010720151732.P2P001

5.3 File Format and Structure Overview

Each transfer file will consist of several record elements in CSV format:
One HEADER record per transfer (Mandatory)
One or more DETAIL records – one per consignment (Mandatory)
One or more ITEM records – one per Item within a consignment (Mandatory only for shipments that require Customs Clearance)
One TRAILER record per transfer (Mandatory)

All files must be Comma Delimited, quotes should be around all string fields. Files should encoded in UTF-8 without Byte Order Marker.

6.2 Country Rules

There are some specific rules for certain countries using particular service codes. Below is a table of the requirements for each.

		1. Item SKU Code is required.
		2. Consignee National ID Number is required.
		3. Payment Reference Number is required.
		4. Payment Date & Time is required.
		5. Consignee Contact Name must be in Chinese characters.
		6. Consignee Address fields must be in Chinese characters.
China	TPDI	7. Consignee Phone is required.
China	TPWW	1. Zip code must be at least 5 digits
		2. Consignee County must be populated with 2 / 3 character state
Australia	TPWW	code.
USA	All	1. Consignee County must be populated with 2-digit state code.
Canada	All	1. Consignee Country must be populated with State or State code
Germany	TPWW	1. Address Line 1 must be a valid house number and street name
